

Stallion Service Contract - Shipment of Live Semen for Holsteiner Stallion Love Affair

This contract is made and entered into by and between Lieselott Wiendieck d/b/a Far-A-Field Acres, LLC, herein designated stallion owner, and _____, mare owner or authorized agent, herein designated mare owner. This is a Stallion Service Contract - Shipment of Live Semen for the 200 – breeding season.

The breeding service fee is \$2,000.00 of which \$300.00 is a non-refundable booking fee which must be paid upon execution of this contract. The remainder of the fee, \$1,700.00 is due prior to shipment of the live semen or by prior arrangement between the parties.

THE MARE OWNER AND STALLION OWNER MUTUALLY AGREE:

1. \$100.00 is also due prior to shipment for costs of transport and for veterinarian fees for collection. Any amount of this additional fee not actually used for the stated expenses shall be refunded by the stallion owner.
2. Stallion owner assumes the responsibility to deliver live semen at the time of delivery to mare owner. Since the ideal time to use the semen is within 48 hours of collection, mare owner agrees to have the semen administered to mare by a licensed veterinarian on the day of receipt by mare owner.
3. Mare owner assumes the responsibility of damage or loss of the shipping container once received by mare owner. In the event of damage or loss of the container after receipt by mare owner, mare owner agrees to pay stallion owner the sum of \$200.00 for said loss or breakage.
4. Mare owner agrees to return container to stallion owner within four (4) days of receipt by mare owner, at mare owner expense and prepaid via an overnight delivery service such as Federal Express.
5. The stallion owner shall not be liable to the mare owner for failure of any mare to produce a live foal for any reason whatsoever.
6. Mare owner has acknowledged and has read the attached material from the American Holsteiner Horse Association regarding breeding and agrees to its rules.
7. This agreement is not assignable or transferable by the mare owner or any other party.
8. Should the mare not deliver a live foal in the year following breeding that can stand up along and nurse as certified in a veterinary certificate delivered to the stallion owner within ten (10) days of such occurrence, mare owner will be entitled to necessary shipments of live semen the following breeding season for not more than three (3) heat cycles for this mare only but must pay all expenses with respect thereto except the booking and live semen fees.
9. This contract is binding upon the parties hereto, may be amended only in writing by the parties and is governed by the laws of the Commonwealth of Virginia.
